

Withdrawal

Right of withdrawal

You have the right to withdraw this contract within fourteen days without giving any reason. The withdrawal period is fourteen days from the date on which you or a representative from your third party other than the carrier of the goods have taken possession of the goods. To exercise your right, you have to with clear explanation inform us* (as a letter by post, fax or e-mail) of your decision to withdraw from this contract. You can do so via the attached sample withdrawal form, however, this is not mandatory. To safeguard the withdrawal period it is sufficient that you send a communication concerning the exercise the right of withdrawal before the withdrawal period.

The right does not apply to goods that are not prefabricated and for their production an individual choice or decision by the consumer is required or which are clearly tailored to the personal needs of the consumer.

Consequences of withdrawal

If you withdraw from this contract, we will reimburse all payments we have received, including delivery costs (except for the additional costs resulting from the fact that you have a type of delivery other than that offered by us and have chosen the cheapest shipping route), immediately and no later than fourteen days from the date on which the withdrawn delivery is back with us and has been entered. For this repayment, we use the same payment method you have used in the original transaction, unless it was agreed with you otherwise; Under no circumstances will we charge any other fees (excluding additional costs that arise when the return was sent to a wrong address or unpaid). We will refuse repayment, until we receive the goods. You have to return the goods promptly and in any event not later than fourteen days from the date on which you inform us of any cancellation of this contract, to the warehouse in your country or Region ** where you received the goods. The deadline is met if the goods are dispatched 14 days before the deadline.

You bear the direct cost of returning the goods. You only need to pay for any diminished value of the goods, if there is a value loss is due to use / mal handling outside from ascertaining the nature, characteristics and functioning of the goods (meaning the goods can be removed for inspection and can be put into operation, but must be returned without any signs of wear and be in a mint condition with all original packaging). Any obvious wear, damage caused by or prolonged use (for example, during a weekend trip) we will deduct from the refund.
